

## **BRIDGETOWN AREA CHAMBER OF COMMERCE MINUTES OF MEETING MARCH 15, 2012**

### **Reports:**

Finance – Operating accounts is currently at \$7739.76

Good Samaritan Acct. - \$ 35.06

Holiday Draw Acct. – \$2175.37 (this is the profit realized from the previous draw). Gary recommended providing the Lions Club with \$500 of this profit for their efforts in the sale of tickets, motion by Dan to accept this recommendation, 2<sup>nd</sup> by John Ray, m/c.

The current holiday draw is underway with posters in merchants windows in town, a calling committee is in place., an email list has been built with approximately 250 contacts, there has been a promotion in the Spectator , Tim advised Lewis would include an ad in the Reader to promote sales. To date there are 21 tickets sold, the BACC will make a decision in April as to continuing with the draw.

### **Ciderfest**

The committee met early this month to solicit ideas, including using the River as a draw and also including an orchard tour. The theme has been rolled out with logo stickers provided to all merchants. Gary advised concrete details for this event will be in place next meeting. Steve advised there may be Queens Jubilee funding available if we tailor an event to meet the requirements. He will forward the information to the committee.

**Carol advised there were 28 people in attendance at the meeting held for the Outdoor Market at Jubilee Park. The market will continue on Tuesdays. Carol has been in touch with Farm Markets of NS and a co-op will be formed to operate the market. Board members to date include Carol, Rachel Edwards and Chantelle MacKinnon. A suggestion for new signage promoting the market was discussed and using the current picket fence signs at both ends of town for market advertising was also suggested.**
