#### **Financial**

**Operating account is currently at \$3294.50**

**Holiday Draw account is \$16,246.90**

**Good Samaritan Account - \$ 35.05**

**There are still outstanding receivables in the amount of \$1897, with \$601 from Ciderfest advertising for a total of \$2498.**

**Holiday Draw- Gary met with the Lions Club and they will discuss at their general meeting on November 20, 2011 if they will operate the draw in 2012/2013. Economic factors are hindering ticket sales, however the BACC will run the draw if the Lions Club does not. Discussions will be held regarding new ideas to promote this event.**

**The projection for the Holiday Draw to end of March 2012 is a break-even point.**

### **Town of Bridgetown**

Steve gave a short report on the forensic audit; there are still some discretionary errors in accounting as to who owes what. Council will be working on budget for next year, hopefully with no significant tax increases. Expenses for the CAO and staff will be included in the budget for next year (with a new council).

Business occupancy tax is now phased out, so the commercial business tax should be even with both. Some assets may be sold to allow for capital reserve. The Foster Lake property is one of these assets.

Nominations for the Bridgetown Area Community Spirit Awards will be in the near future, Steve is currently working on this project.

Dan advised that the Town should talk with the Herald with a positive spin instead of the terrible article and photos they published. This has been damaging to our Town. Andy suggested businesses should promote each other in a positive manner, such as the Bank of Nova Scotia winning their district award. It is up to our residents and businesses to write the next chapter of our town's story.

### **Old Business**

Cluster Business Education- The federal government has money available to be used in small business education, classes require seven or more employees to run. There is a survey online to learn more about this project.

### **New Business – Moonlight Madness**
